### IQ 2000 Training Course

#### Purpose of the Training Course

The course is for people who are responsible for controlling the finances of a small business or those who are responsible for the bookkeeping or accounting aspect of financial management in organizations.

#### Qualifying learners will be able to:

- Create a Company in IQ 2000.
- Setup all necessary default settings.
- Record Debtors, Creditors and Stock.
- Process Opening balances for Debtors, Creditors and General Ledger.
- Process Receipts and Payments for Debtors and Creditors.
- Process Cashbook entries for both Cash and Bank.
- Process Invoices, Credit Notes, Goods Received Vouchers, Returned Goods.
- Process Purchase and Sales Orders, Job Cards and Quotes.
- Process Bills of Quantity (Manufacturing)
- Process Cash Purchases and Cash Sales.
- Process Cash Sales via POS (Point of Sale).
- Process Petty Cash.
- Prepare POS (Point of Sale) Reports.
- Record Cash up's.
- Process End of Day Procedures.
- Reconcile Creditor's Statements.
- Prepare Debtor's Statements.
- Prepare Financial Statements (Trial Balance, Balance Sheet and VAT).
- Prepare Stationery (Statement Layout, Invoice Layout etc...).
- Learn the ease of using filters.

#### Learning Assumed to be in Place and Recognition of Prior Learning

It is assumed that learners have a basic understanding in Accounting and have PC Skills in Microsoft Windows.

- Creating Creditor Accounts, Maintaining Creditors, Creating Standard Account Transactions, Editing / Creating Transaction Types, Allocations, Post Dated Cheques, Generating Reports and Creditors Month End.

##### **Inventory**

- Creating and maintaining of Stock Inventory Items, Stock Groups, Stock Departments, Repts and Stock Inventory Month End.

#### Day 2

##### **Stock Inventory Transactions for Suppliers and Customers**

- Posting Supplier Invoices (GRV), Posting Return to Supplier (RTS), Posting Customer Invoices (INV), Posting Credit Notes (CRN), Stock Adjustments and Generating Inventory Reports.

##### **Purchase Orders**

- Brief Overview, Creation and Maintenance of Purchase Orders, Processing of Purchase Orders, Converting Purchase Orders to Goods Received Vouchers, Purchase Order Reports.

##### **Sales Orders**

- Brief Overview, Creation and Maintenance of Sales Orders, Processing of Sales Orders, Converting Sales Orders to Invoicing, Sales Order Reports.

##### **Job Cards**

- Brief Overview, Creation and Maintenance of Job Cards, Processing of Job Cards, Converting Job Cards to Invoices, Job Card Reports.

##### **Bills of Quantity**

- Brief Overview, Maintenance of Bills, Capturing of Stock for Manufacturing, Manufacturing, Disassembling, Bill of Quantity Report.

##### **General Ledger, Cash Book and Journal Processing**

- Creation of General Ledger Accounts, Managing the General Ledger Chart of Accounts, Processing of Cash Book Entries, Processing Transactions through Journals, Bank Reconciliation, Generating Financial Reports (Trial Balance, Balance Sheet etc...) and Year End Processing.

### Day 3

#### **Point of Sale Configuration**

- Setting up of Slip detail, Setup Promotions, Overview of different Tender Types (cash, cheque, credit card etc...), Configuration of Hardware (Receipt Printer, Cash Drawer etc...), Store Parameters, Cashier Security, Default settings.

#### **Point of Sale (Sales)**

- Processing Cash Sales, Account Sales, Cash Refunds, Account Refunds, Suspended Sales, Processing Customer (Debtors) payments via Point of Sale, Additional functionality (price lookup, view/store sales, reprinting of documents) Processing Petty Cash Transactions.
- Generating Point of Sale Reports, Processing End of Day procedure (POS Reports, Cash up, End of Day)

#### **Utilities**

- Creation and preparation of Stationery Layouts (Invoices and Statements)
- Preparing and creating of filters within different modules of the IQ 2000 package (Debtors, Creditors and Stock) for reporting purposes.
- Backing up Company Data, Restoring your Company Data.
- Creation of Users, Passwords etc...
